BRAND COMPLIANCE AUDIT

INSTRUCTIONS • QUESTIONNAIRE

You will visit the assigned location to confirm if any Chester's Chicken or BirdShack branding is present.



Before You Begin

- Confirm location hours and address
- Review brand guide to become familiar with examples of how names/logos may appear
- Review photo requirements



Don't Forget!

- Search exterior/interior for specific branding
- Take clear photos of all required areas
- Take photos of any signage or packaging with assigned brand's name or logo
- Make required purchase & get receipt



General Requirements

- Read all instructions and the entire questionnaire before you complete the shop.
- Confirm business hours before arriving. Do not arrive within 30 minutes of closing.
- Make sure you visit the correct address.
- Be prepared to spend 10-15 minutes at the location browsing to ensure Chester's (or BirdShack) names or logos are no longer present. The brand you're assigned to look for will be listed in your shop confirmation.
- Photos are required if any Chester's (or BirdShack) names or logos are observed and to clearly show logos have been removed from signage and packaging.
- Do not reveal yourself as a mystery shopper.
- Make required food and beverage purchases and upload receipt with report.
- Submit your report to shopperhub.cxgroup.com within 12 hours of completing the shop.
- Retain all documentation for six months following your shop.
- You or your immediate family members cannot currently or have ever worked for the company of the store you're visiting or Chester's Chicken/BirdShack.



Shop Instructions

Go to the exact address provided in your email

If the store is no longer in business or has changed names, you are still required to travel to the site to capture all required photos you can at that address. If the interior is not accessible, be sure to note this in your report.

Browse entire exterior and interior for Chester's (or BirdShack) branding and take photos

Chester's Chicken and BirdShack Branding Guide

- Check your shop confirmation for which brand you will be auditing and review the above branding guide.
- If you find the assigned brand name or logo anywhere outside or inside the location, please take a clear photo of the signage.
- Try to be discreet when taking photos if possible. Remain casual and friendly during the audit.
- Take all the following required photos and upload them with your report:

EXTERIOR PHOTOS:

- Both sides of any roadside/monument signs
- Each of the 4 sides of the store

NOTE: Try to clearly capture signage affixed to the building in this image, including any marquees or other signs physically attached to the building. If it is difficult to clearly show this in the store-side photo AND there are Chester's (or BirdShack) names or logos on the signage, please take additional photos.

- Wide shot of the front of store

NOTE: Try to clearly capture window and door clings in this image. If it is difficult to capture this in the wide-angle storefront photo AND there are Chester's (or BirdShack) names or logos on signage, please take additional photos.

- Window signs and/or clings

INTERIOR PHOTOS:

- Counter area (where food is ordered)

NOTE: If possible, try to capture menu boards, hot food/deli case, above case and countertops in the image. If it is difficult to capture these in one photo, AND Chester's (or BirdShack) names or logos are present, please include additional photos.

- Food and beverage packaging (for chicken and sides purchased and any that may be visible on counter)

- ❖ Be sure any branding on the packaging is shown in the photo

- ❖ Include food packaging, any exterior bags and beverage cups in the photo

- TV menu board (if present)
- Any POP signage (if present)

Miscellaneous Branding: In addition to observing the specific signage and packaging provided in the sample branding guide, you are also required to browse the location to ensure no additional materials are displayed with Chester's (or BirdShack) names or logos. If so, please take photos of the branded item(s).

Look for fresh chicken, place order, and obtain a receipt

- Browse the interior to confirm if any fresh chicken products are being sold.
- Note the types and brands of any fresh chicken items being offered at the counter and if sides were present.

- If available, you must order any tender or bone-in chicken menu item, mac & cheese or mashed potatoes and a beverage from the counter. (\$15 reimbursement)
- If these items are no longer available, purchase any food and beverage from the location. Obtain a copy of your receipt to upload with your report.
